

RESOLUTION NO. 2499

A RESOLUTION OF INTENTION TO MAKE CHANGES
AND MODIFICATIONS IN ASSESSMENTS AND
IN BOUNDARIES OF ASSESSMENT DISTRICT

DOWNTOWN PARKING ASSESSMENT DISTRICT

RESOLVED, by the City Council of the City of El Paso de Robles, California, that it is the intention of said Council to make changes and modifications in the assessment and in the boundaries of the assessment district, including a modified description of acquisitions and improvements to be made and accomplished as all of the foregoing was described in Resolution of Intention No. 2352, adopted by this Council on October 2, 1979, as follows:

1. Change and modify the boundaries of said assessment district by including those particular parcels of property more particularly shown and designated on that certain assessment diagram, as revised, on file with the City Clerk and open to inspection by any interested party.

2. As a result of the modification of said boundaries, the description of the work and acquisitions to be accomplished is hereby modified to read as follows:

- a) The acquisition of property, building demolition, business relocation, utility relocation, excavation, asphalt paving, sidewalks, curb and gutter construction, landscaping and striping to provide for a complete off street parking facility in, on or about the following parcels: San Luis Obispo County Assessor's Parcel Nos. 9-036-15, 16, 17 and 26; 8-324-3; 9-044-6; 9-046-3; and, 9-102-1.
- b) The acquisition of necessary easements, rights-of-way, lands and appurtenances required for the acquisition and construction of the above facilities and necessary to complete the same.

3. The total amount of the assessment proposed to be levied for the cost of the improvements upon the lots or parcels benefited is increased from \$925,829.00 to \$ 952,611.50.

4. That in accordance with Section 3113 of the Streets and Highways Code of the State of California, the City Clerk shall file a copy of the revised assessment diagram herein described, in the office of the County Recorder of the County of San Luis Obispo at least ten (10) days prior to the date set for hearing as hereinafter provided.

NOTICE IS HEREBY GIVEN that Tuesday, the 18th day of November, 1980, at the hour of 7:30 o'clock p.m., at the regular meeting place of said Council, Council Chambers, City Hall, 1030 Spring Street, Paso Robles, California, are hereby fixed as the time and place when and where said Council will consider the making of said changes and modifications in the assessments, description of work and boundaries of the assessment district and hear all protests and persons interested therein.

The City Clerk shall cause a copy of this Resolution to be published once in the local newspaper published and circulated in said City and to mail a copy of this Resolution to all property owners proposed to be included in said assessment district, said publication to be at least ten (10) days before the date of hearing and said mailing to be at least twenty (20) days prior to said hearing date.




