

RESOLUTION NO. 2531

A RESOLUTION REQUESTING CANCELLATION OF PROPERTY
TAXES ON MUNICIPALLY OWNED PROPERTY

WHEREAS, the City of El Paso de Robles has acquired several parcels of land used for municipal purposes including parcels used for airport clearzone, parcels used for drainage basins, parcels used for wastewater treatment facilities, parcels used for access to solid waste facilities, and parcels to be used for municipal off-street parking district, and

WHEREAS, attached hereto as Exhibit "A" is a list of the various parcels owned by said City showing the date, volume and page where deeds to properties were properly recorded, a description of each parcel and the public use which the City assigned to each parcel, and

WHEREAS, said properties were assessed on the County Tax Roll at the time of purchase with taxes thereon not paid.

THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles that the City Clerk of said City be and he is hereby directed to forward a certified copy of this Resolution to the Board of Supervisors of the County of San Luis Obispo as a request to order the Tax Collector of said County to cancel all uncollected taxes, penalties and costs heretofore levied upon the above described property and any assessment being placed for future tax purposes.
