

RESOLUTION NO. 2563

A RESOLUTION APPROVING GRANT OF EASEMENT  
FOR  
ROAD PURPOSES

WHEREAS, the CITY OF EL PASO DE ROBLES has negotiated for the acquisition of property for Municipal Airport Clear Zone purposes; and

WHEREAS, as a part of the consideration the CITY OF EL PASO DE ROBLES has agreed to grant a 60 foot wide easement for roadway purposes to ARCHIE E. HANSON, JR., MARY A. HANSON, DONALD LEWIS and EDITH E. LEWIS, as set forth on the Grant of Easement attached hereto as Exhibit A and by this reference incorporated herein.


