

RESOLUTION NO. 2574

A RESOLUTION APPROVING ANNEXATION NO. 45
BREIDEN/THUNDERBIRD

WHEREAS, a petition for annexation of the hereinafter described property has been filed; and

WHEREAS, the Local Agency Formation Commission approved Annexation No. 45 subject to the following terms and conditions:

1. Revised maps and legal descriptions must be submitted to the Deputy Executive Officer and checked for compliance (these were received and checked April 17, 1981);
2. The City must prezone the property and one (1) certified resolution designating pre zoning must be submitted to the Deputy Executive Officer;
3. The City must conduct a hearing on the annexation, since 100% landowner approval was not received, and six (6) certified copies approving the annexation must be submitted to the Deputy Executive Officer;
4. The City Manager must complete the Certificate RE: terms, conditions, and indebtedness and return this to the Deputy Executive Officer; and
5. The State Board of Equalization filing fee of \$430.00 must be received by the Deputy Executive Officer; and

WHEREAS, maps and legal descriptions have been revised and are attached hereto as Exhibit "A"; and

WHEREAS, the property has been pre zoned pursuant to Ordinance No. 459 N.S.; and

WHEREAS, a public hearing was held on May 19, 1981 at which all interested parties were heard; and

WHEREAS, a certificate entitled Terms, Conditions and Indebtedness for Annexation No. 45 has been completed for said annexation; and

WHEREAS, it is authorized that the filing fee of \$430.00 be forwarded to Deputy Executive Officer of LAFCO; and

NOW, THEREFORE, BE IT RESOLVED that the annexation of territory hereinafter described and designated "Annexation No. 45" is approved subject to said annexed area being taxed to pay its proportional share of the outstanding bonded indebtedness of the City of El Paso de Robles.

RESOLVED FURTHER, that the City Clerk is directed to transmit a certified copy of this resolution to the Executive Officer of the Local Agency Formation Commission together with fees required by Section 54902.5 of the Government Code of the State of California and any other attachments germane.
