

RESOLUTION NO. 2605

RESOLUTION OF THE CITY COUNCIL APPROVING
A REPORT UNDER THE "SPECIAL ASSESSMENT
INVESTIGATION, LIMITATION AND MAJORITY
PROTEST ACT OF 1931", AND FIXING A DATE
OF HEARING THEREON.

WHEREAS, the CITY COUNCIL of the CITY OF EL PASO DE ROBLES, CALIFORNIA (hereinafter referred to as "Agency"), has by Resolution ordered the preparation of a "Report" under the provisions of the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931", being Division 4 of the Streets and Highways Code of the State of California, relating to the construction of certain public works of improvement in a special assessment district known and designated as:

ASSESSMENT DISTRICT NO. 81-01
(NIBLICK BRIDGE)

(hereinafter referred to as the "Assessment District"); said works of improvement generally described as follows:

The construction of certain bridge improvements, together with appurtenances, generally located near the southerly City limits of the City, crossing the Salinas River. The proposed bridge, together with the approach street and road improvements, will have two traffic lanes and generally will connect SPRING STREET to SOUTH RIVER ROAD. The bridge will be approximately 1,360 feet long, with the approach road being approximately 2,000 feet for the SOUTH RIVER ROAD connection. An alternate may be considered to connect to NIBLICK ROAD;

and,

WHEREAS, such "Report" has been prepared and submitted to Agency.

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

SECTION 1. That the above recitals are true and correct.

SECTION 2. That the "Report" so prepared and presented be, and the same is approved, and the fact and date of this approval shall be endorsed thereon and the "Report" shall be filed in the Office of Agency.

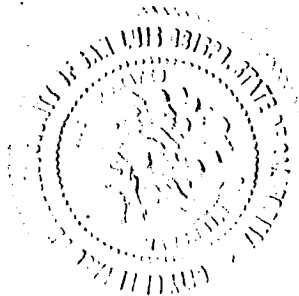
SECTION 3. THAT THIS AGENCY DOES HEREBY FIX THE 14TH DAY OF OCTOBER, 1981, AT THE HOUR OF 7:30 O'CLOCK P.M., AT THE SPECIAL MEETING PLACE OF AGENCY, BEING THE PASO ROBLES HIGH SCHOOL, LOCATED ON NIBLICK ROAD, AS THE TIME AND PLACE WHEN A HEARING ON SAID "REPORT" SHALL BE HELD BY AGENCY. THE CITY CLERK SHALL GIVE NOTICE OF SUCH HEARING BY MAILING A COPY OF THE NOTICE, POSTAGE PREPAID, TO ALL PERSONS OWNING REAL PROPERTY WHICH IS PROPOSED TO BE ASSESSED TO PAY ANY PART OF THE COST OF THE WORK, WHOSE NAMES AND ADDRESSES APPEAR ON THE LAST EQUALIZED ASSESSMENT ROLL AVAILABLE ON THE DATE THE "REPORT" WAS COMMENCED, AT THE ADDRESS AS SHOWN ON SUCH ROLL, OR AS KNOWN TO AGENCY, ALL IN THE MANNER AND FORM AS PROVIDED FOR IN SAID DIVISION 4 OF THE STREETS AND HIGHWAYS CODE OF THE STATE OF CALIFORNIA.


