

RESOLUTION NO. 2713

RESOLUTION CALLING A PUBLIC HEARING TO DETERMINE WHETHER PUBLIC NECESSITY,  
HEALTH, SAFETY, OR WELFARE REQUIRES THE FORMATION OF UNDERGROUNDING  
UTILITIES DISTRICT IN THE CITY OF EL PASO DE ROBLES

BE IT RESOLVED by the City Council of the City of El Paso de Robles as follows:

WHEREAS, Ordinance No. 297 N.S., establishes the procedure for the creation of Underground Utility Districts and the requirements as the initial step in such procedure the holding of a public hearing to ascertain whether public necessity, health, safety or welfare requires the removal of poles, overhead wires and associated overhead structures and the underground installation of wires and utilities for the supplying of electric, communication, or similar or associated service in any district; and

WHEREAS, it has been recommended that such an Underground Utility District, hereinafter called District No. 4 be formed within the boundaries of an area as shown on that map marked Exhibit "A" and attached hereto.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. NOTICE IS HEREBY GIVEN that a public hearing will be held by the City Council of the City of El Paso de Robles on April 6, 1982, at the hour of 7:30 p.m. in the City Council Chambers of the City Hall, Paso Robles, California, to ascertain whether the public necessity, health, safety or welfare requires the removal of poles, overhead wires and associated structures and the underground installation of wires and facilities for supplying electric, communication or similar associated services in the District hereinabove described.

2. At such hearing all persons interested shall be given an opportunity to be heard. Said hearing may be continued from time to time as may be determined by the City Council.

3. The City Clerk shall notify all affected property owners as shown on the equalized assessment roll and the utilities concerned of the time and place of such hearing by mailing a copy of this resolution to such property owners and utilities concerned at least ten (10) days prior to the date thereof.

4. The area proposed to be included in the District is now shown upon that certain map entitled "Underground Utility District No. 4", dated March 9, 1982, which is on file in the office of the City Clerk of the City of El Paso de Robles.

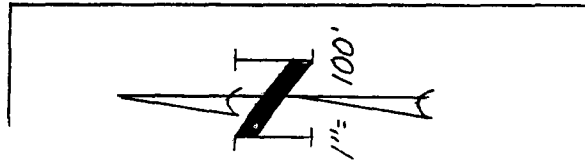


