WHEREAS, both Mayor Schwartz and Mayor Pro Tem Minshull have chosen not to run for public office in 1982; and


WHEREAS, it is most proper for our Mayor and Mayor Pro Tem to be recognized by their fellow Councilmen for their long and dedicated service;




