RESOLUTION NO. 2824

A RESOLUTION ESTABLISHING SEWER RATE DECREASES

WHEREAS, Section 14.16.020 (Section 2 Ordinance No. 292 N.S.) of Chapter 14.16 of the Municipal Code of the City of El Paso de Robles, requires the establishment of Sewer Service Charges and permits the City Council, from time-to-time, to set the amount of paid charges, and;

WHEREAS, Resolution No. 2573 requires that annual changes will be affected July 1st of each year based upon the upward or downward movement of the Consumer's Price Index for Urban Wage Earners and Clerical Workers, San Francisco - Oakland, California, all times - Series A (1967=100) (index) published by the U.S. Department of Labor, Bureau of Labor Statistics for any change above or below the January 1, 1980, figure; and

WHEREAS, the CPI for Urban Wage Earners and Clerical Workers issued for April, 1983, (294.7) shows a percentage decrease from April 1982 (297.8) of 1.0%,

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of El Paso de Robles that all sewer rates be decreased as identified in Exhibit 'A' attached and made a part of this resolution to be effective July 1, 1983.



EXHIBIT A

WASTEWATER FUND RATE DECREASE EFFECTIVE JULY 1, 1983

A. MINIMUM RATE CHARGE:

The minimum charge for classes whose rate is based on usage shall be \$5.45 per month for the first 500 cubic feet of water used per month. All usage over 500 cubic feet per month shall be added at their respective rates. Each dwelling unit included in any such establishment shall also pay an additional \$5.45 per month.
