

RESOLUTION NO. 2834

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
EL PASO DE ROBLES
APPROVING THE APPLICATION FOR FUNDS FROM THE
PARK RESTORATION AND URBAN REFORESTATION PROGRAM
PUBLIC LAW 98-8

WHEREAS, the people of the State of California have enacted Public Law 98-8, which provides funds for the Park Restoration and Urban Reforestation Program; and

WHEREAS, the Resources Agency of California has been delegated the responsibility for the administration of the program within the state, setting up necessary procedures governing application by local agencies under the program; and

WHEREAS, said procedures established by the Resources Agency of California require the applicant to certify by resolution the approval of applications prior to submission of said applications to the state; and

WHEREAS, said applications contain assurances that the applicant must comply with; and

WHEREAS, the applicant agency will enter into an agreement with the State of California, or its authorized agencies, for the restoration and rehabilitation of its park lands.

NOW, THEREFORE, BE IT RESOLVED that the City of El Paso de Robles


1. Approves the filing of an application for funds from the Park Restoration and Urban Reforestation Program for the restoration and rehabilitation of the City Park.
2. Certifies that said agency understands the assurances and certification in the application; and
3. Certifies that said agency has or will have sufficient funds to operate and maintain the project upon completion; and
4. Certifies that said agency has reviewed and understands the instructions of the work plan; and

Appoints the Director of Parks and Recreation as agent of the City to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, amendments, and so in which may be necessary for the completion of the aforementioned project.


