RESOLUTION NO. 2855 CITY OF EL PASO DE ROBLES

A RESOLUTION OF THE CITY OF EL PASO DE ROBLES TO THE SAN LUIS OBISPO COUNTY LOCAL AGENCY FORMATION COMMISSION RELATIVE TO A PROPOSAL TO ANNEX TERRITORY TO THE CITY OF EL PASO DE ROBLES DESIGNATED "CHAROLAIS WATER TANK"

BE IT RESOLVED by the City Council of the City of El Paso de Robles, that:

1. The Council of the City of El Paso de Robles does hereby consent to the proposed annexation and does request the San Luis Obispo County Local Agency Formation Commission to approve the annexation of the territory described in the attached "Exhibit A" and designated "as above" to the City of El Paso de Robles.

2. This Council declares that:

- A. This proposal is made pursuant to Section 35012 of the Government Code.
- B. The territory proposed to be annexed is uninhabited as that term is defined in the Government Code of the State of California.
- C. The reasons for this proposal are that:
 - (1) The City of El Paso de Robles has purchased said property from L. S. Killian and Mary Killian, husband and wife
 - (2) The City of El Paso de Robles intends to hold and develop the parcels for a City Reservoir
 - (3) The City of El Paso de Robles will be able to provide all municipal services to the area

3. The City Council requests that the proposed annexation be wholly approved by the San Luis Obispo County Local Agency Formation Commission, unconditionally.

4. The City Council requests that application and processing fees be waived for this annexation.




