RESOLUTION NO. 90- 75

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES REQUESTING AN AMENDMENT OF THE SPHERES OF INFLUENCE AND SERVICE

WHEREAS, Government Code Section 56428 authorizes the City to request amendments to the Spheres of Influence and Service; and

WHEREAS, applications for the following annexations have been or will be filed with LAFCO and each annexation will require amendments to the Spheres of Influence and/or Service:

1. Annexation #64: Filed by Neil Olsen for 200 acres located on the south side of Linne Road and on the west side of Hanson Road at the City's eastern limits;
2. Annexation #67: Filed by Tom Erskine for 11 acres located between 12th and 17th Streets at the City's western limits;
3. Annexation #68: Filed by Warnke, Crockett, and Phillips for 28 acres located south of 12th Street and west of Merryhill Road at the City's western limits;
4. Annexation #69: To be filed by the City for 2,324 acres generally located north and south of Highway 46 East and east and west of Airport Road;

WHEREAS, at its meeting of May 7, 1990, the City Council approved General Plan Amendment 90-02, which established land use categories for Annexations 67, 68, and 69, and conducted the first readings for their respective Rezones 90003, 90007, and 90005 to establish rezoning for these annexations; and

WHEREAS, at a study session on February 15, 1990, the Council indicated that it would consider inclusion of the 200 acres owned by Neil Olsen within the Spheres of Influence and Service, but indicated that annexation, general plan amendment, and rezoning should wait for completion of the General Plan Update Program;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of El Paso de Robles, California, pursuant to Government Code Section 56428, to request that LAFCO set a time for hearing to consider the change in the City Spheres of Influence and Service to include all land within proposed Annexations 64, 67, 68, and 69 as shown on the map attached as Exhibit A and tables listing Assessor's Parcel No.'s for each annexation attached as Exhibit B.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to transmit to the Executive Director of LAFCO, a certified copy of this resolution and those application fees required by LAFCO; and

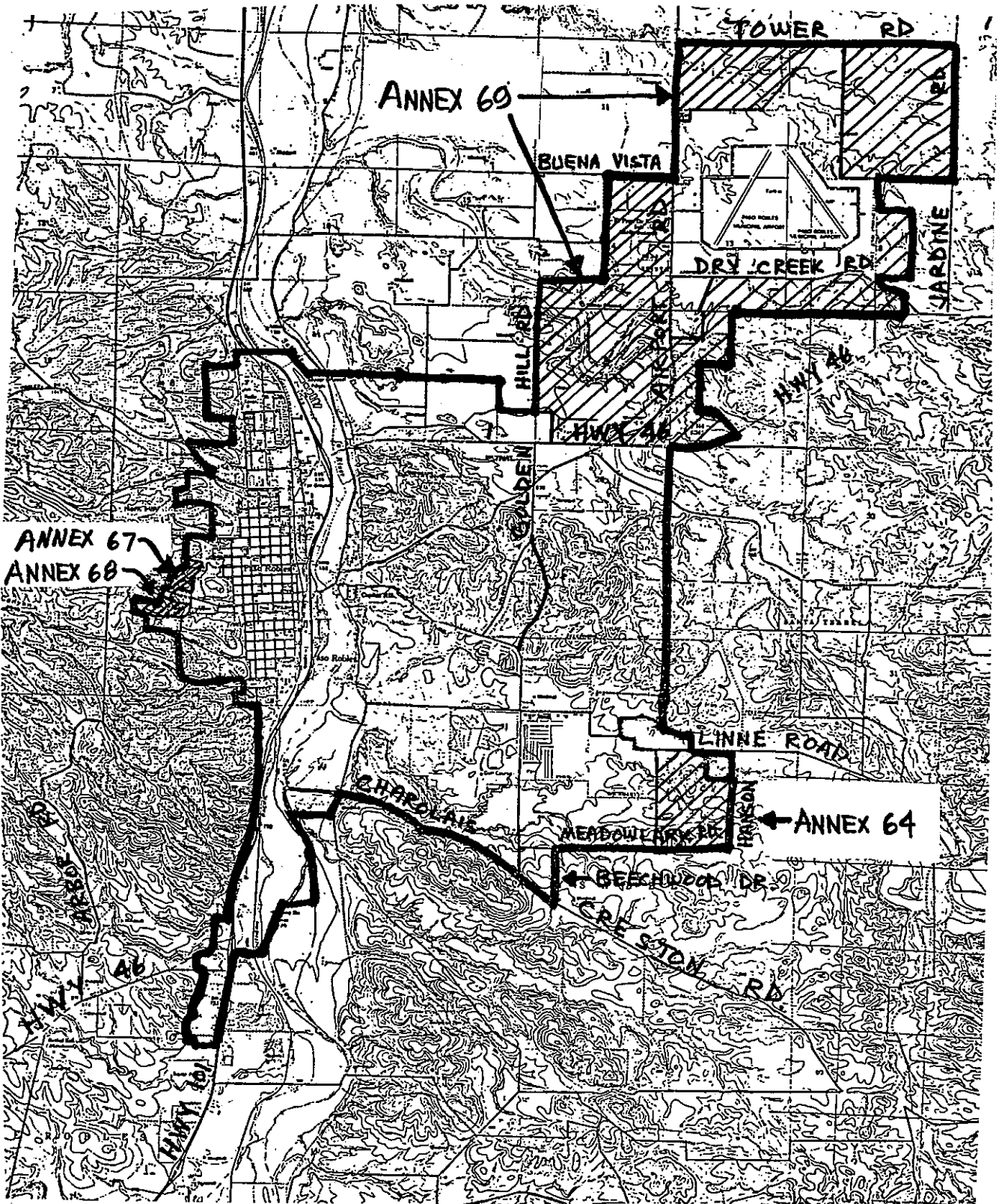
