RESOLUTION NO. 92-72

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES,
CALIFORNIA, AS ANNEXING TRACT 1723 AS SUBAREA 11 TO THE
"PASO ROBLES LANDSCAPE AND LIGHTING DISTRICT NO. 1"
(STREETS AND HIGHWAYS CODE SECTIONS 22500, ET SEQ.)

WHEREAS, pursuant to Resolution No. 91-123, the City
Council has previously initiated proceedings and declared its
intent to annex Tract 1723 to Landscape and Lighting District No.
1 ("District"); and

WHEREAS, the owners of the real property have consented in
writing to annexation into the District.

NOW, THEREFORE, the City Council of the City of El Paso de
Robles, California, does resolve as follows:

1. It is hereby declared that the real property located in
the City of Paso de Robles, County of San Luis Obispo, as more
particularly described in Exhibit "A" hereto, is hereby annexed to
the Paso Robles Landscape and Lighting District No. 1 and that all
landscape and lighting improvements required as conditions of
approval of Tract 1723 be installed by the developer.

2. The current owner of the real property, according to the
Petition for Formation of the District, is SWIFT DEVELOPMENT, INC.

3. The assessment for this fiscal year (1991-92) shall be
zero.

4. The area annexed shall be designated Paso Robles Landscape and Lighting District No. 1, Subarea .



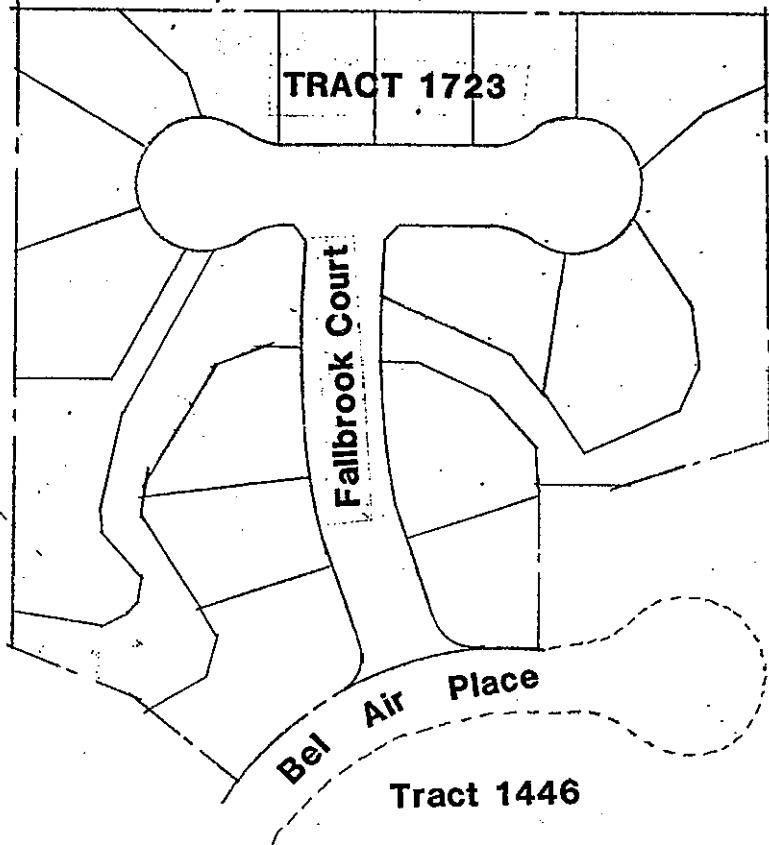
Tract 276

Golf Course

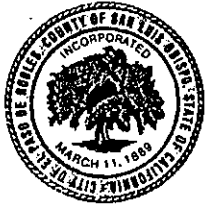
