**A RESOLUTION OF INTENTION FOR VACATING A PORTION OF
BEECHWOOD DRIVE AND GIVING NOTICE OF A TIME AND
PLACE FOR A PUBLIC HEARING THEREON**

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES does hereby resolve as follows:

1. That it is the intention of the City council to close and vacate a public right-of-way in Beechwood Street in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

The easterly twenty-five feet (25') of Beechwood Drive as shown on Tentative Parcel Map PR 91-091.

2. For further particulars as to the proposed vacation, reference, is hereby made to a map and plan now on file in the Office of the City clerk of the City of Paso Robles.

3. That in the event of said closing, as hereby and above described, the City of Paso Robles may reserve a permanent public utility, water, sewer, drainage and access easement over the entire vacated street.

4. That November 3, 1992, at the hour of 7:30 P.M., on said date in the Paso Robles School District Board Room, 800 Niblick Road, Paso Robles, California, is the time and place set forth for hearing all persons interested in or having objection to the proposed closing.

5. That the City Clerk of the City of Paso Robles be and is hereby directed to cause a copy of this Resolution of Intention to
