

RESOLUTION NO. 94 - 16

RESOLUTION REQUESTING CONSOLIDATION OF
GENERAL MUNICIPAL ELECTION TO SUBMIT
MEASURE "A" TO THE VOTERS, REQUESTING
SERVICES OF THE SAN LUIS OBISPO COUNTY CLERK
IN CONDUCTING THE ELECTION AND
AUTHORIZING THE BOARD OF SUPERVISORS TO
CANVASS THE ELECTION RETURNS

THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES
RESOLVE AS FOLLOWS:

Section 1. Pursuant to section 36508 of the California Government Code, a general municipal election will be held in the City of El Paso de Robles on June 7, 1994.

Section 2. Pursuant to Part 2.5 (commencing with section 23300) of the California Elections Code, the City Council hereby requests consolidation of its general election with the statewide election to be held on June 7, 1994. Said general election shall be for the purpose of submitting Measure "A" to the qualified electors of the City of El Paso de Robles. A copy of the resolution calling said election together with the text of the measure is attached hereto.

Section 3. Pursuant to section 22003 of the California Elections Code, the City Council hereby requests the Board of Supervisors of the County of San Luis Obispo to authorize the County Clerk to render all services otherwise required to be performed by the City Clerk for the general election to be held on June 7, 1994. Such services include, but are not limited to:

- Publication of Notices calling the election
- Publication of Notices calling for arguments
- Arrangements for receiving center
- Provision of precinct maps
- Obtaining and staffing polling places
- Hiring and training of precinct workers
- Provision and delivery of precinct supplies
- Provision of microfiche of voters and poll locations, if desired
- Counting of ballots and certification of election
- All aspects of election not specified above which may be agreed upon by the County Clerk and the City Clerk

Section 4. The Board of Supervisors is hereby authorized and directed to canvass the returns of the election and to certify the results of the election to the City Council as required by law.

Section 5. The City of El Paso de Robles shall reimburse the County of San Luis Obispo for all costs and expenses incurred by the County in conducting said election upon presentation of a bill to the City.


