RESOLUTION NO. 94-20

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF EL PASO DE ROBLES VACATING A PORTION OF CANYON CREST LANE
IN TRACT 1508-2 IN THE CITY OF EL PASO DE ROBLES**

WHEREAS, the City of El Paso de Robles, having on the 4th day of January, 1994, passed a Resolution of Intention to close and vacate a public Street in the City of El Paso de Robles, County of San Luis Obispo, State of California, and more particularly described as follows:

That portion of Canyon Crest Lane in Tract 1508-2, from the northerly line of Canyon Crest Lane cul-de-sac to the northerly boundary of said Tract 1508-2, in the City of El Paso de Robles, County of San Luis Obispo, State of California as shown in Book 15, Page 84 of Maps on file in the county Recorder's Office of Said County and State.

WHEREAS, it now appears that the City of El Paso de Robles did cause said Resolution of Intention to be published in the Country News as required by law; and

WHEREAS, it further appears that said notices and public actions were in all respects completed as required by the provisions of an act of Legislature of the State of California entitled "Street Vacation Act of 1941" Division IX, Part 3, Chapters 1 and 2 of the Streets and Highways Code; and

WHEREAS, a public hearing has been held on said proposed vacation as so noticed and having heard all evidence offered by any person interested, the City Council of the City of El Paso de

Robles finds that the street as described is unnecessary for present or prospective future public street purposes.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. That the street vacation herein before described be vacated for public street purposes.

BE IT ALSO RESOLVED, that the City of El Paso de Robles does hereby reserve and except from said vacation a permanent easement and right-of-way for the purpose of maintaining, operating, replacing or removal of utility lines over, under and across all of the vacated area herein described with ingress and egress rights for said purposes including access for the protection of said facilities from all hazards.

BE IT FURTHER RESOLVED, that the City Clerk of the City of El Paso de Robles cause a certified copy of this Resolution to be recorded in the Office of the County Recorder of the County of San Luis Obispo, State of California.
