

**RESOLUTION NO. 98-49**

**A RESOLUTION OF THE CITY COUNCIL  
OF THE CITY OF EL PASO DE ROBLES  
CHANGING THE NAME OF ENGINE  
AVENUE TO GERMAINE WAY  
(ABANDONMENT/STREET NAME 98002)**

**WHEREAS, both Government Code (section 34091.1) and Streets & Highway Code (section 5026) allows the City to change a street name; and**

**WHEREAS, Engine Avenue is located off of Tractor Street in the City of Paso Robles and no properties have been given an Engine Avenue addressed; and**

**WHEREAS, a Tentative Tract Map 2269 has been approved by the Planning Commission north of the Engine Avenue; and**

**WHEREAS, Street "A" within Tentative Tract 2269 will connect to Engine Avenue; and**

**WHEREAS, the City's Department of Emergency Services requires that a single street name be used Street "A" and Engine Avenue; and**

**WHEREAS, the developer of Tentative Tract 2269 as filed an application, Abandonment/Street Name 98002, to name Street "A" Germaine Parkway and change the name of Engine Avenue to Germaine Parkway; and**

**WHEREAS, at its meeting of March 24, 1998, the Planning Commission took the following actions:**

- a. Considered the facts and analysis, as presented in the staff report prepared for the street name change;**
- b. Conducted a public hearing to obtain public testimony on the street name change;**
- c. Recommended that the City Council change the name of Engine Avenue to Germaine Way; and**

**WHEREAS, at its meeting of April 7, 1998, the City Council took the following actions:**

- a. Considered the facts and analysis, as presented in the staff report prepared for this application;**
- b. Considered the recommendations of the Planning Commission; and**
- c. Conducted a public hearing to obtain public testimony on this application;**

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. That the City Council of the City Council of the City of El Paso de Robles does hereby authorize the name change of Engine Avenue to Germaine Way.

Section 2. That the City Council of the City Council of the City of El Paso de Robles does hereby authorize staff to record necessary documentation with the San Luis Obispo County Clerk and San Luis Obispo County Surveyor to effect the change of street name.


