

RESOLUTION NO. 00-59

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES  
AUTHORIZING USE OF COMMUNITY DEVELOPMENT BLOCK GRANT ADMINISTRATIVE FUNDS  
FOR THE PROCESSING OF A CONDITIONAL USE PERMIT APPLICATION FOR  
LOAVES AND FISHES NEW FACILITY AT 2650 SPRING STREET

WHEREAS, Loaves and Fishes is a non-profit organization that operates a social service facility that provides emergency food and referrals to emergency shelter to persons in Paso Robles that are in need; and

WHEREAS, Loaves and Fishes must relocate from their current quarters in a City-owned building, which is scheduled to be demolished, to a new location; and

WHEREAS, Loaves and Fishes has been offered a donated site for their new facility at 2650 Spring Street, a property that is zoned C-2; and

WHEREAS, social services facilities require approval of a conditional use permit in the C-2 Zone; and

WHEREAS, the City of El Paso de Robles (the "City") charges applications for conditional use permits fees for recovering the City's staff time and related costs (publishing of newspaper notices, mailing hearing notices, copying of reports) for processing such applications; and

WHEREAS, Loaves and Fishes has requested that the City Council of the City of El Paso de Robles (the "City Council") waive City fees for processing a conditional use permit application; and

WHEREAS, At its meeting of March 16, 1999, the City Council adopted Resolution 99-41 determining those projects to be funded with the City's allotment of 1999 Community Development Block Grant (CDBG) Funds; and

WHEREAS, Resolution 99-41 provides that \$20,000 in 1999 CDBG funds are to be allocated to Loaves and Fishes to be used for the purposes of operating expenses (rent payments, furnishings, and/or equipment), tenant improvements and/or other necessary site improvements to assist Loaves and Fishes relocate to a new location; and

WHEREAS, Resolution 99-41 also provides that \$64,000 in 1999 CDBG funds are to be allocated for administrative and "capacity building" purposes; and

WHEREAS, CDBG administrative and capacity building fees may be used for staff time and related expenses for processing permits for CDBG-funded projects;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES DOES HEREBY RESOLVE AND FIND AS FOLLOWS:

SECTION 1. The City Council hereby authorizes that expenses incurred by the City for processing a conditional use permit application for Loaves and Fishes be charged to 1999 CDBG administrative funds, and that Loaves and Fishes need not deposit fees with their application for a conditional use permit for their proposed new facility .

SECTION 2. The City Council hereby stipulates that the authorization set forth in Section 1 is limited to the use of CDBG processing of a conditional use permit application and in no way is to be considered a pre-approval of such an application to establish a social service facility at 2650 Spring Street or at any other location in the City of Paso Robles.
