

RESOLUTION NO. 02-45

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES  
AWARDING THE CONTRACT FOR PALM COURT/SHANNON HILL/TANNER WATERLINES  
TO D-KAL ENGINEERING AND AUTHORIZING  
EXECUTION OF THE CONTRACT

WHEREAS, the Water Master Plan identifies upgrading the existing 4-inch diameter waterlines along Tanner Drive, Palm Court and Shannon Hill Road to 8-inch diameter to improve water delivery to residences and businesses located in this part of the City;

WHEREAS, in accordance with the Public Works Construction Act, the City advertised for bids, providing plans and specifications to both plan rooms and all requesting individuals; and

WHEREAS, the twenty (20) bids were received by the specified deadline were publicly opened at the noticed Bid Opening on March 7, 2002. The range of bids went from \$153,121 to \$365,500, with the low bid submitted by D-Kal Engineering in the amount of \$153,121.00; and

WHEREAS, City staff reviewed all bids and recommends that the bid be awarded to D-Kal Engineering in the amount of \$153,121.00; and

WHEREAS, City Council adopted a Capital Improvement Program (CIP) appropriating the budget for these waterline upgrades in June 2000 (DPW 01-12); and

WHEREAS, by awarding the low bid, and considering other project costs and contingencies, \$850,000 needs to supplement DPW 01-12 to complete the project.

THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. That the City Council of the City of Paso Robles does hereby award the bid for the Palm Court, Shannon Hill, and Tanner Waterlines to D-Kal Engineering in the amount of \$153,121.00.

SECTION 2. That the City Council of the City of Paso Robles does hereby authorize the City Manager to execute the contract with D-Kal Engineering for Palm Court/Shannon Hill/Tanner Waterlines.

SECTION 3. That the City Council does hereby approve additional appropriations as follows:
