

RESOLUTION NO. 03-96

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF EL PASO DE ROBLES
DECLARING THE RESULTS OF A PROPERTY OWNER PROCEEDING AND
APPROVING CERTAIN RELATED ACTIONS

WHEREAS, the City Council of the City of El Paso de Robles, California (hereafter referred to as "City Council") called and duly held a property owner protest proceeding for certain Sub Areas within the Landscaping and Lighting Maintenance District No. 1 (hereafter referred to as "District") pursuant to the provisions of the *Landscaping and Lighting Act of 1972, Part 2 of Division 15 of the Streets and Highways Code of California, beginning with Section 22500* (hereafter referred to as "Act") and the *California Constitution Articles XIII C and XIII D*, for the purpose of presenting to the qualified property owners within the District the annual levy of assessments for the costs and expenses of the landscaping, street lighting and appurtenant improvements providing special benefits to the properties within; and

WHEREAS, the landowners of record within certain Sub Areas of the District as of the close of the public testimony portion of the public hearing held on June 17, 2003, did cast their ballots, the results of which are illustrated below:

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PASO ROBLES, CALIFORNIA, DOES HEREBY RESOLVE, ORDER AND DETERMINE:

SECTION 1. The above recitals are true and correct.

SECTION 2. The results of the tabulation of the valid property owner ballots returned by the property owners within said Sub Areas of the District, prior to the conclusion of the public hearing and property owner protest proceeding held for the District on June 17, 2003, is hereby confirmed and made a public record.

SECTION 3 If the tabulation of the valid property owner ballots returned by the property owners within said Sub Areas of the District indicates approval of the increased assessment and the assessment range formula, the City Council is hereby authorized to take the necessary steps to levy the increased assessments as approved. For any Sub-Area for which the tabulation of the valid property owner ballots indicates disapproval of the increased assessment and the assessment range formula, the property owners in such Sub-Area shall continue to be assessed at the current level.

SECTION 4 The City Clerk is hereby directed to enter this Resolution on the minutes of the City Council which shall constitute the official declaration of the result of such property owner protest proceeding.

SECTION 5 This Resolution shall become effective immediately upon its adoption.

SECTION 6 The City Clerk shall certify the adoption of this Resolution.
