Permit Conditions

The applicant understands and acknowledges that Paso Robles Department of Emergency Services has the right to enter and inspect for which the permit is issued for compliance with the laws, rules, and regulations enforced by the City of Paso Robles. The applicant acknowledges and agrees to pay all costs incurred by the City of Paso Robles in securing any judicial writ or inspection warrant to fulfill that right wherein the applicant fails to give consent for inspection. Said costs shall include all personnel time and court costs incurred by the City of Paso Robles to procure any judicial writ or inspection warrant.

Application is made to the Paso Robles Department of Emergency Services for inspection and approval of the described operation or activity which must conform to all applicable standards. No operation or activity requiring a permit will be performed until a permit is received. We understand working without approved plans and a permit will result in delays and additional fees.

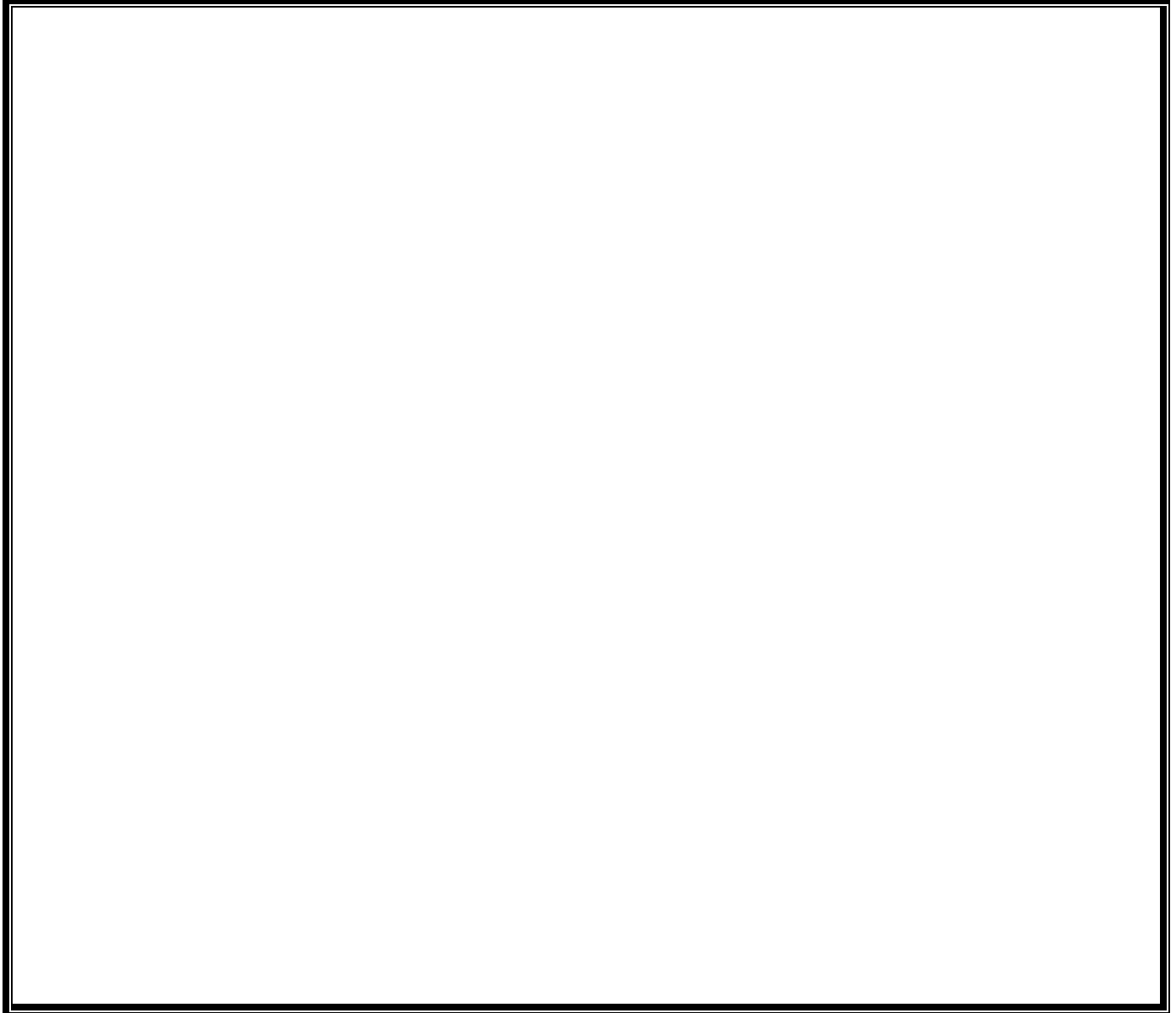
