

**NOTICE OF REQUEST FOR QUOTATION**

**Biosolids Hauling from Paso Robles Wastewater Treatment Plant to Paso Robles Landfill**

Notice is hereby given that the City of Paso Robles is inviting proposals for biosolids (processed sewage sludge) hauling from the Paso Robles Wastewater Treatment Plant to the Paso Robles Landfill. All proposals must be received by the Department of Public Works by **5:00 PM on November 6, 2009**, at City Hall (2nd Floor), 1000 Spring Street, Paso Robles, California, 93446.

Proposals received after said time will not be considered. Each proposal shall be plainly marked "**Biosolids Hauling – Closing Date – November 6, 2009.**" Proposals shall be submitted using forms available from the City.

Proposals shall state the per ton cost of hauling for two years starting January 1, 2010, and extending through December 31, 2011. The estimated tonnage per year to be hauled is 3,000 tons. Payment will be made based on actual tonnage hauled. The City will pay the landfill dumping fees. All proposals shall include hauling and loading of sludge and are to be based on a per-ton basis. The haul process requires an end-dump trailer and hauling takes place approximately every two to three months. The work shall be performed in accordance with all applicable laws. Proposers must be able to provide insurance as described in the contract documents.

Proposals received after the designated time will not be accepted.

**All proposals will be required to remain valid for a period of ninety (90) days.**

The City reserves the right to reject any or all proposals; to make any awards or any rejections in what it alone considers to be in the best interest of the City, and waive any informalities or irregularities in the bids. The contract, if awarded, will be awarded to the responsible proposer who submits lowest responsive bid.

The successful bidder must insure that employees and applicants for employment are not discriminated against on the basis of age, color, race, national origin, ancestry, religion, sex, sexual preference, marital status, and shall comply with the Americans with Disabilities Act.
