Subject: Follow-up Correspondents Regarding May 5th Council meeting, Public Hearing: Drought Response

Dear Mayor and Council Members,

We wish to comment further regarding the previous email below that was sent to City Council members on May 1.

During the past several days we received comments regarding our correspondents. We fully appreciate that staff and Council members' time is "stretched". However, as homeowners we are working within the regulatory process that has been established by the City to govern our L&LD.

In response to comments we wish to add the following points to the previous May 1 correspondence:

- * As citizens of this community we understand and appreciate staff workload; however, it's City policy that homeowners pay staff annually to administer the L&LDs business. We rely on you.
- * City staff pays the bills and administers the District's maintenance contracts. Homeowners' fees are collected annually in support of that work.
- * Staff needs to analyze the L&LD annual water and maintenance savings in relation to meeting the State's new drought water reduction regulations of 19% this year and 28% overall.
- * Should Council cut off water to street parkway turf, you should direct staff to work with the maintenance contractor to complete the drip conversion as soon as possible to keep trees healthy.
- * The City will need to adjust the L&LD maintenance contract in response to not watering, mowing and maintaining the large turf areas.
- * Savings should be used to convert the street parkway irrigation infrastructure to a drip system for trees.
- * Our District will meet or exceed the City's 19% overall water reduction goal by drying up all the turf areas.
- * Street trees should not receive a death sentence because of new state turf watering regulations. Street trees are an asset to our community and the environment.

We understand the need to reduce water consumption and our L&LD homeowners have been working towards that goal with the assistance of City staff for the past two years. We appreciate Council members

taking the time to understand our neighborhood concerns regarding drought regulations you will be considering at Tuesday's Public hearing.

Before closing we want to thank Freda Berman and Nate Wyatt for their help and assistance with our L&LD. They have been outstanding to work with.

Thank you again for your consideration regarding this very important matter.

Subject: May 5th Council meeting, Public Hearing: Drought Response

Dear Mayor and Council members,

I wish to address Agenda Item #1, Drought Response Report scheduled for a Public Hearing next Tuesday, at your May 5th Council meeting.

In the staff report under **Analysis and Conclusion**, Item 2a and b, "*City managed irrigation systems*", the report calls for the following:

"a) *cease irrigation of street median and parkway turf*"

"b) *Cease irrigation within Landscape and Lighting districts*"

Our Del Oro/Hacienda L&LD; Zone 10, Sub Areas 72 A, B, C and D neighbors have been working with City Public Works staff for over a year to significantly reduce water consumption in the District. Last week on Wednesday evening, April 29th, residents met and voted to reduce turf area irrigation by over 50% in our basin and shared park areas in addition to the elimination of turf at the two entrance areas leading into the Del Oro subdivision in accordance with new State regulations.

It's my strong belief the total L&LD will meet and exceed water savings required in the new State water regulations.

However, elimination of irrigation for *'parkway turf'* as noted in item 2.a above, will be a death sentence to the hundreds of beautiful trees that line our streets and provide a positive environmental oasis for all 171 homes. Short of killing the trees, I would strongly suggest all parkway turf sprinklers be capped and sprinkler heads adjacent to each tree be converted to a drip system to provide adequate tree irrigation. The turf area could be removed and/or drought tolerant plants added and the median covered in bark to help prevent moisture evaporation.

In conclusion, as homeowners we understand the critical need to save water and have agreed to significantly reduce massive turf areas by over 50% within our L&LD. We will meet the water reduction for the entire L&LD. I urge the City Council and staff to work with us and prevent the loss of hundreds of our trees that can never be replaced.

Thank you for your consideration regarding this extremely important matter.

Greetings Mayor Martin and Council Members.

Due to a prior commitment I am not able to attend the Council meeting of May 5, 2015, and voice my objections to Item 10, (Airport Lease evaluation etc.) on the agenda.


My objections are;

- The expenditure of \$28,000 for analyzing our Airport leases is very untimely. There are no significant leases coming up for renewal for over 20 years and we have not signed a new lease in 17 years (Treana Winery). I am certain we will not attempt to force any recommended changes to our lease policies on existing leases.
- Local real estate professionals would be much more knowledgeable of the local Industrial/commercial real estate market. Our local real estate professionals will have to educate the "out of town" consultant and we will pay for that knowledge. There is a very large supply of developed industrial property in and adjacent to Paso Robles with 67 more acres in the pipe line. Why not just use our local real estate professionals to arrive at a fair market value for our available industrial property and keep the money in Paso Robles ?
- As for Airport air side land lease policy and rates. There have been no serious Inquires or applications for air side leases in recent memory. The rental rate of one half cent per month/square foot for properties lacking sewer and natural gas along Dry Creek Rd, have not generated any results, even at this very low rate. There is no demand. Price is not the issue. An out of state consultant attempting to use any comparisons with other airports within California or without, will not be of any use. Local demand is the issue. Demand in the aviation community (Piston single & light twin) that populates our airport, is in decline. This is nation wide. Hangars will continue to become available. There is a 17% hangar vacancy factor at surrounding airports (City Staff) and several on our Airport as well, 47 non flying aircraft populate our Airport and some will leave in time, adding to the hangar vacancies here.
- Why not spend money completing the Airport perimeter fence and security gates. This improvement will bear an immediate benefit to our Airport. How about a general clean up of the native vegetation along Airport Road and initiate a chemical sterilization program for areas like this?

In conclusion, I would request that this issue, at a minimum. be returned to staff (option b)for a more comprehensive review . There is no hurry for this lease review as stated above. Why not take a little more time to properly evaluate our Airport with more non aligned public input.

Mr. Mayor and Members of the Council,

Unfortunately I am in Europe on business and can not attend the council meeting on May 5. Most of you know me, my career in aviation, and what I have contributed to improve the airport.

As the Estrella Warbirds Museum President and as a former large lease holder on the airport, I have some major concerns with the direction that is about to be set in motion at the airport. A few concerns:

1. With the airport deep in the red financially, why do we need to pay a consultant to tell us what is already known. It won't make the red ink go away.
2. I read the "Airport Business Improvement Plan" from the PRAA. It really addresses none of the current issues, and does not show a pathway to profitability. For example, where's the what, how, when, and where?

These are just a few of many of my and our museum's concerns. It is vital that we discuss this further before making any decisions. This airport can be a major revenue generator for the city and its citizens. I implore you to table this discussion for a short period. It would be in the best interest of the city, it's airport tenants, and concerned citizens to do so. We all need a more thorough dialog before such a decision is thrust upon the airport tenants and citizens of Paso Robles.
