3. **City Council Recommendation for Tobacco and Cannabis Ban** (*Plescia*)
The adoption of a tobacco retailer license with a comprehensive ban on flavored tobacco and cannabis products, and a ban on e-cigarettes being sold in the city locally and online.
Moved and seconded by Seden-Hansen/Ramos to approve the vote in favor to recommend this to City Council – motion carried.

Our city's approach to the polystyrene situation will now be defined by those rules, enforced by the IWMA.
