

RESOLUTION NO. 13-031

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PASO ROBLES
DIRECTING STAFF TO IMPLEMENT A STREET MAINTAINANCE PLAN

WHEREAS, a temporary ½ cent Sales Tax Measure was passed in the recent election; and

WHEREAS, it is estimated that \$2,700,000 will be received in FY 2013/2014; and

WHEREAS, it is recommended that field work is needed to implement either Plan.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

SECTION 1. The City Council of the City of El Paso de Robles does hereby direct staff to implement Plan B.

SECTION 2. The City Council does hereby direct staff to use Budget No. 103-910-5452-334 (Sales Tax Revenue Fund) to track costs

SECTION 3. The City Council does hereby direct staff to engage the services of Pavement Engineering, Inc. to gather field data for a not-to-exceed fee of \$136,145 with a \$13,855 contingency.






